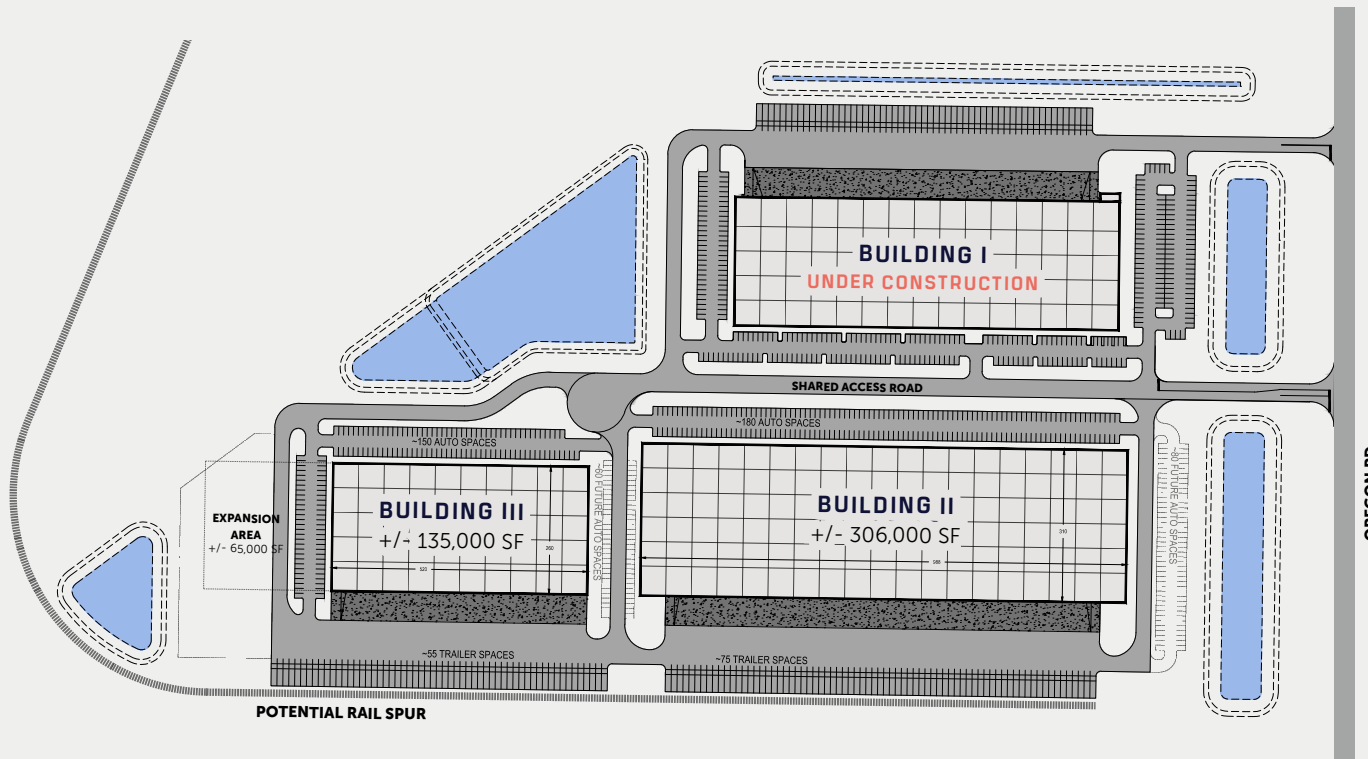
THREE-BUILDING CONCEPTUAL SITE PLAN

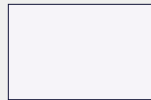

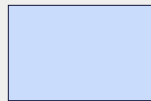

SURROUNDING LABOR POOL

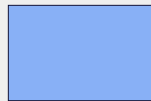
BLUE COLLAR LABOR DENSITY



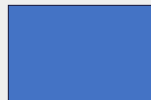

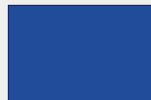

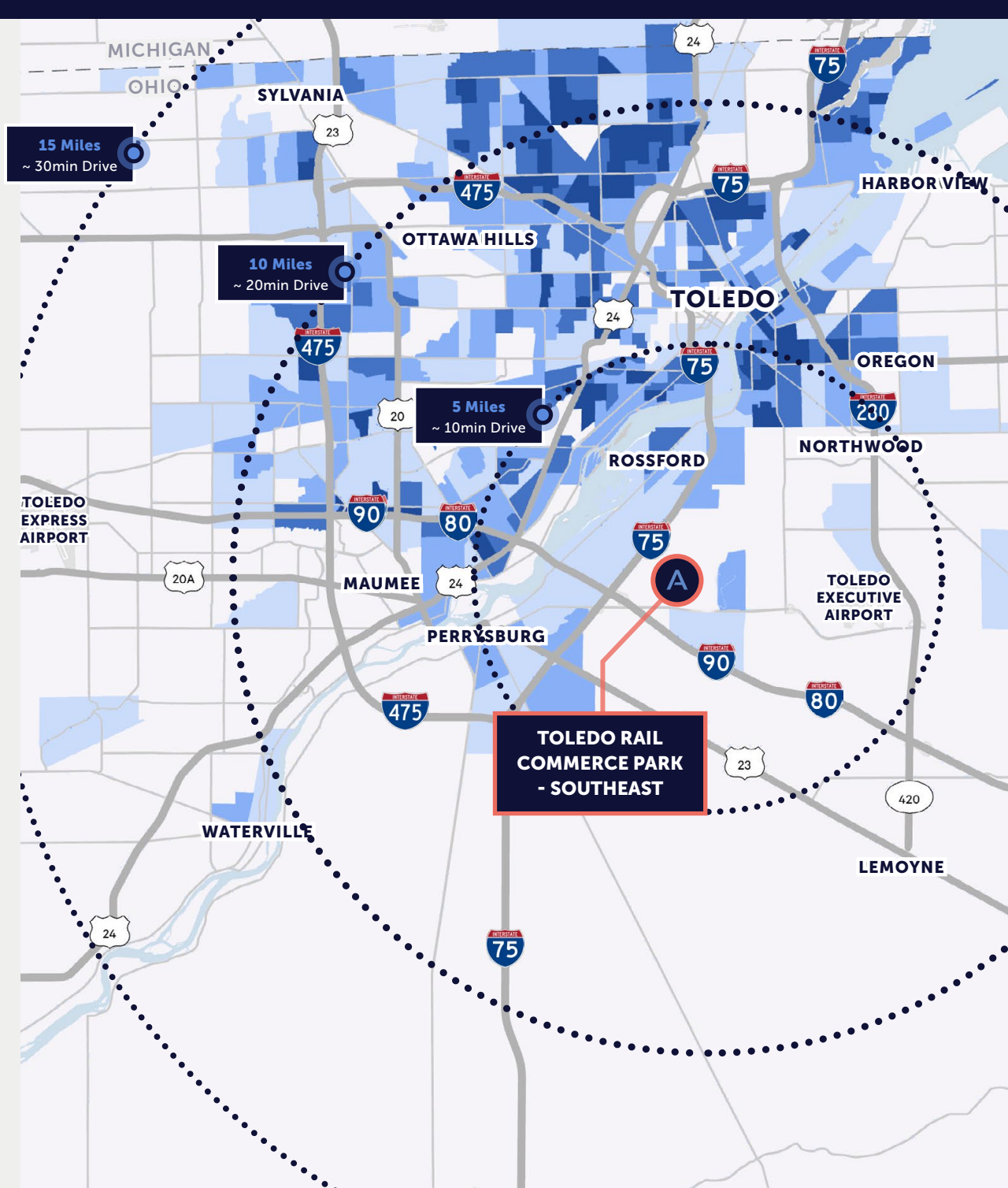
